A MESSAGE FROM OUR PRESIDENT

October 1, 2020

Dear PBS Michiana - WNIT Stakeholder:

Thank you for your ongoing interest, viewership, and support in the mission of public television in our Michiana region. This past fiscal year, October 1, 2019 – September 30, 2020, was one in which our organization needed to make great adjustments to our operations and mission priorities. We stepped up and did not hunker down.

In a great way, we were reminded that the essence of public television is in our educational roots. At our core, WNIT is an educational institution. As we saw our school systems severely challenged by the Coronavirus pandemic limiting their ability to conduct in-person classes, we knew WNIT needed to help support at-home learning and we have.

Beginning last March and continuing into 2021, WNIT created a special, temporary, at-home learning channel, 34.5. It is available off antenna or through several cable systems. We provide programming linked to on-line study guides which are emailed, weekly, to each K12 school district in WNIT's coverage area. For a period of time, during the general shut-down portion of the pandemic, we also provided a *daily* email of tips for parents who were teaching their students at home. This expanded the use of on-line study guides carried through to our early learning programming and other selected programs on our channels 34.1, 34.2, and 34.3.

This at-home learning challenge continues today for our K12 schools. We are in the process of using our broadcast signal in additional ways such as helping to plug that gap between students who have internet broadband service in their homes and those who don't. Watch for this and more in 2021.

It has always been my philosophy that public television should compliment commercial television and not compete. We took that approach to pandemic issues. While we provided a great deal of information about the medical aspects of the virus, PBS Michiana – WNIT took the lead with a series of programs coping with the mental health issues created by the stress and isolation viewers endured.

While remaining a 24/7 operation and not missing a beat, WNIT took precautions with our staff, providing daily health check protocols, workplace distancing, limiting visitors, adjusting in-building work hours, and changing our production techniques. Most of our in-studio productions were shifted to using video teleconferencing systems, such as Zoom, to conduct interviews. Some of our on-location based productions increased safety measures, but some productions had to be entirely postponed to 2021. All-in-all, our staff did a superb balancing act to respond to community needs and the responsibilities of our mission with personal safety.

As we explored the mental health aspects of this virus crisis, we were greatly concerned about our youngest viewers who aren't always able to verbalize what they are feeling. Daniel Tiger's Neighborhood is one of PBS Michiana – WNIT's most popular early learning programs. We developed a campaign to reach out to children and encourage them to make a home video sending a message of love and support to older adults in isolation and nursing homes, hopefully putting a smile on many viewers' faces.

Mission comes first, but you need financial support to perform that mission. PBS Michiana – WNIT was fortunate to have the backing of our member-viewers. Thank you to all the individuals who recognized the stresses on our organization and increased their giving.

We are also appreciative of the PPP (Payroll Protection Program) loan and a special "stabilization grant" from the Corporation for Public Broadcasting (CPB) which, along with internal expense controls, prevented any furloughs of our staff.

There were ups and downs in other revenue areas, but as you will see as your review our financial report, WNIT made it through FY 2020 in respectable financial condition.

This pandemic was a horrible event to happen to our world, nation and community. It forced WNIT to think back to its mission core and to operate in different directions. I think we are a better, more focused organization going into 2021.



WNIT Provides Proactive Community Engagement



WNIT launched the PBS Kids 24/7 Channel on WNIT on June 24, 2019, giving the children in the Michiana area free, 24/7 educational programming to help combat the high percentage of children that do not have access to high-quality preschool education.



With the onset of the COVID19 pandemic, area schools and parents had an increased need for At-Home Learning materials and educational curriculum. WNIT served this need in 2020 with the PBS Kids 24/7 Channel and by launching a temporary channel on channel 34.5. While PBS Kids offers children ages 2-8 educational programming across a spectrum of learning domains including literacy, STEM (science, technology, engineering and math) and social emotional learning, the new channel was launched to provide curriculum for grades 6-12.

The WORLD At-Home Learning Service, a partnership of PBS and WGBH - Boston was offered locally over-the-air on temporary channel 34.5 and on Comcast channel 1160, beginning in March and continues to air. The WORLD Channel is available weekdays from Noon – 5:00 p.m.

WNIT publishes programming schedules and corresponding curriculum resource materials focusing on key subject areas. The curriculum resources from PBS LearningMedia are a free online service of thousands of educational tools. Television program schedules have been augmented with information about grade-level appropriateness, subject area focus, and learning objectives.

WNIT Prides Itself in Civic Engagement





Connecting Michiana's citizens to their government is a primary mission of WNIT. From the local level to the federal, WNIT has provided a forum where elected officials can go beyond sound bites in discussing policy and citizens can express their concerns directly to their representatives.

Michiana Access TV

WNIT is contracted by St. Joseph County and the cities of South Bend and Mishawaka to produce Michiana Access Television on Comcast Cable and AT&T U-Verse. In this venture, WNIT provides the facilities and personnel needed for private individuals to broadcast, at no charge, their own public access television shows.

This channel also broadcasts council meetings and other events for South Bend, Mishawaka and St. Joseph County. MATV can be found on channel 99 on both cable systems.




